BYLAW 3.2023

A BYLAW TO PROVIDE FOR ENTERING INTO AGREEMENT WITH THE Town of Rosthern respecting the joint funding of certain recreation facilities;

The Council of the Rural Municipality of Rosthern No. 403 in the Province of Saskatchewan enacts as follows:

- 1. The Rural Municipality of Rosthern No. 403 is hereby authorized to enter into Agreements attached hereto and forming part of this bylaw, and identified as Exhibit "A" with the TOWN OF ROSTHERN.
- 2. The Reeve and Administrator for the Rural Municipality of Rosthern No. 403 are hereby authorized to sign and execute the attached agreements identified as Exhibit "A".
- 3. That bylaw 7.2017 be repealed.

THE TOWN OF ROSTHERN (the "Town")

WHEREAS The Town owns and operates public recreation facilities known as the Rosthern Jubilee Sports Centre (JSC) and the Valley Aquatic Centre (VAC).

AND WHEREAS the Town and RM recognize common interests and want to ensure all their residents have the opportunity to participate in a variety of leisure activities in the areas of sport, culture and recreation at a reasonable cost.

NOW THEREFORE THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1) The Town shall continue to operate the JSC and VAC facilities under the Parks and Recreation Department of the Town.
- 2) The RM agrees to contribute the following annual grants for the operation of the facilities:
 - a) Twenty Thousand dollars (\$15,000.00) per annum for the JSC.
 - b) Fifteen Thousand dollars (\$12,500.00) per annum for the VAC.
- 3) The Town agrees to invoice the amounts listed in section 3) to the RM at the end of each calendar year and the amounts owing by the RM shall be paid to the Town withing sixty (60) days of the invoice date.
- 4) The Town agrees to provide the RM with a detailed statement of revenue, expenditures and net operating cost for each facility on an annual basis and no later than March 1st of each year.
- 5) Annually, the RM agrees to designate a portion of their population for the Sask Lotteries Community Grant to the Town. The Town agrees to develop and maintain a policy in order to fairly disperse the Sask Lotteries Community Grant funds to eligible community organizations and that the policy and any amendments will be provided to the RM.

6) It is understood and agreed that this agreement shall apply for the year 2023 and shall continue in force for the years 2024 and 2025, but the agreement may be terminated by either party to the agreement by giving sixty (60) days' written notice.
