Overweight Permit Policy Resolution of Approval # 492.2019 (November 2019 Meeting) Amendment (Section 1 & 10) August 2020 Meeting Resolution of Approval #324.2020

Policy Objective:

To regulate the issuance of Overweight Permits on Municipal Roads.

For the purpose of this policy, “Municipal Roads” shall mean all roads in the RM 403 except Provincial Highways.

For the purpose of this policy, “Overweight Permits” shall mean any weights over Secondary weights on Municipal Roads.

For this purpose of this policy, “per day” shall mean a 24 hour period, and “yearly” shall mean a calendar year of January 1st to December 31st of the current year.

Policy:

The Rural Municipality of Rosthern will charge fees for Overweight Permits within the boundaries of the RM of Rosthern 403.

The annual tender for the RM gravel program are exempt from all fees relating to the program. Dates shall be determined annually by Council. These permits will be issued as needed by Administration.

1) Fees for Overweight Permits in the RM are as follows:

Permit Type	Cost
Day Trip Permit	\$50.00
Yearly Permit	\$300.00
Per Load During Road Bans for Construction ONLY	\$100.00

3) That speed limits for the Municipal Roads be reduced to Sixty (60) Kilometers per hour.

4) That permits are subject to road ban restrictions and road conditions as set out by the Municipality or by the Ministry of Highways.

5) Owner of the permit is responsible to meet vehicle equipment regulation standards.

- 6) That the Vehicle must be registered with SGI for the gross weight of the public highway.
- 7) No permit shall be issued without the payment of appropriate fees to the Municipal Office.
- 8) In the case of the Administrator not be in the office staff have authority to issue the said permits.
- 9) Should the owner require any additional copies of the permit charges as per request for information policy shall apply.
- 10) That a permit may be issued during road bans for Construction Purposes ONLY, and that the permit only be valid during the times of 6:00AM and 10:00AM at a cost of \$100/load.
