Hi Council and Rate Payers,

Below is information required within the Discretionary Use Application Form for the RM of Rosthern.

- a) We are proposing to extract, process, store, and sell aggregate located on the Buhler Land, located on the North 80 acres of NE-22-40-3-W3.
- b) It is our intention to utilize the existing approach on the land regarding access and egress. We would expect to do concentrated hauls from this particular location. This would result in some days being up to 50 loads hauled, and would carry on for a week or two at a time. Then hauling would likely be fairly minimal until we obtain the next contract.
- c) We wouldn't require any lighting or signage.
- d) During crushing operations, there would be approximately 4 employees on site. Crushing per contract would usually only take 2 weeks to a month per time. These crushes would usually only occur as contracts are obtained. The crushes could happen during any given season. Working hours would generally be from 7am-7pm.
- e) Rock in this pit is relatively small, therefore noise wouldn't be a large factor. Piles that are produced would act as a natural sound barrier. Dust is usually quite minimal.
